

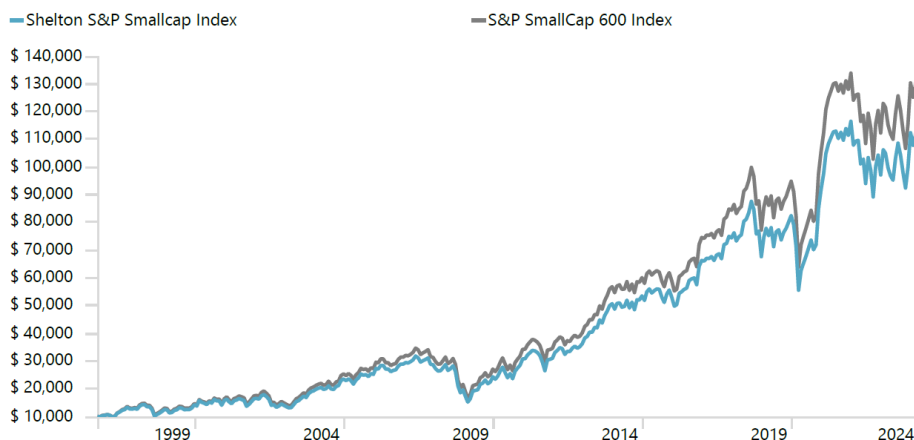
Fund Objective
