

## Fund Objective

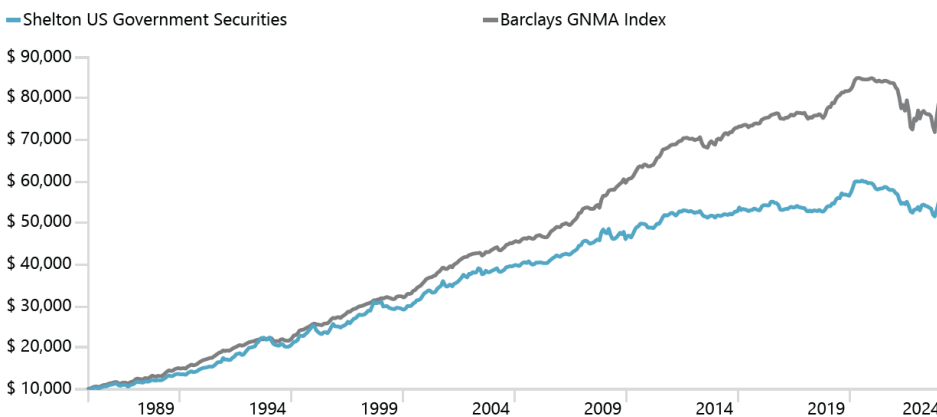
The Fund's investment objective is to seek liquidity, safety from credit risk and as high a level of income as is consistent with these objectives.

- Target duration is usually three to twelve years

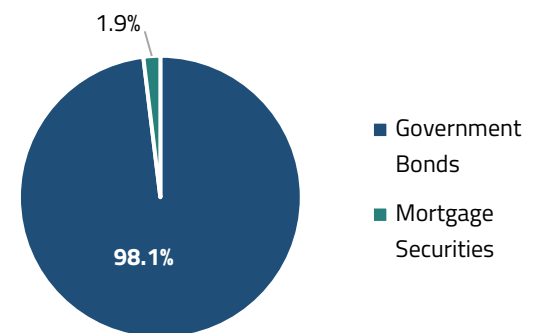
