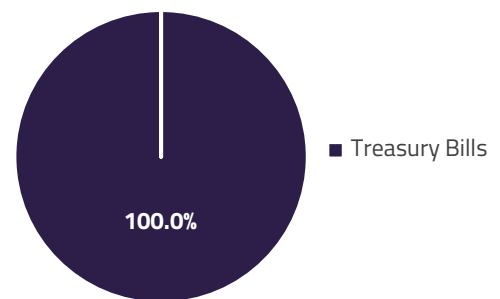
- The Fund will invest at least 99.5% of its total assets in cash, government securities, and/or repurchase agreements collateralized by cash or government securities
